

Terms & Conditions

Please read through the terms and conditions below. When joining Bosman Ballet Flow as a member or attending class as a casual attendee, you agree to the terms and conditions as below.

General

- 1. All purchases of services (classes, workshops, courses and events) are non-refundable.
- 2. Purchases of products (merchandise) are refundable in new and unused condition up to 10 days after purchase.
- 3. For casual class attendance, payment must be made upon booking or paid in cash at time of attendance.
- 4. Bosman Ballet Flow is not responsible for the safekeeping of your personal belongings.
- 5. It is the responsibility of the attending member/visitor to notify Bosman Ballet Flow of any previous injury, illness, or conditions that may impact their practice.
- 6. Classes at Bosman Ballet Flow may be physically strenuous and you voluntarily participate in them with full knowledge that there is risk of personal injury.
- 7. Bosman Ballet Flow reserves the right to refuse entry.
- 8. Prices may increase from time to time to reflect increases in costs.
- 9. By booking into a class you automatically agree to the above terms & conditions.

Class & Workshop Cancellations

- 1. Please cancel if you are unable to attend a class or a workshop to make your space available to others.
- 2. Class cancellations must be made with a minimum of 12 hours' notice. If you do not provide notice of cancellation and there is a waiting list for this class, two (2) credits will be deducted from your BBF card.

Class Package Validity

All class packages are valid for **12 months** from **date of purchase**. There is no 'carry-over' of unused credits. You will receive notification **14 days** before card expiry.

Card expiry dates can be paused by mutual agreement for travelling, medical or bereavement reasons.

In order to allow for use of a class package across different mediums (standard studio class, advanced studio class, Zoom class and video recordings), BBF uses a 'credits' system as follows:

- 1. Five (5) credits for a 75 minute studio class
- 2. Four (4) credits for a standard 60 minute studio class
- 3. Three (3) credits for a standard 60 minute Zoom class
- 4. Two (2) credits for receiving a video recording of a standard 60 minute class

Class Packages available:

- 1. BBF 28 Credit Package (i.e. 7 x standard studio classes @ 4 credits per class)
- 2. BBF 48 Credit Package (i.e. 12 x standard studio classes @ 4 credits per class)
- 3. BBF 160 Credit Package (i.e. 40 x standard studio classes @ 4 credits per class)
- 4. BBF 360 Credit Package (i.e. 90 x standard studio classes @ 4 credits per class)
- 5. BBF Unlimited (any class of any duration)
- 6. Credit packages may be shared between members of the same family. The same expiration dates apply to shared packages.

Gift Cards

- 1. Gift cards can be redeemed for classes, workshops, courses, account credit, and/or retail purchases.
- 2. Gift cards are non-refundable and not redeemable for cash.
